The Captiva Civic Association (CCA) will not accept payment on behalf of any exhibitor. Also if selected, exhibitor agrees to pay a \$50 registration fee and will notify CCA at least 30 days prior to event if exhibitor can no longer participate. If the CCA finds another acceptable exhibitor as a replacement, then the registration fee can be refunded, but is otherwise nonrefundable. The CCA will not receive any commission from the sales during this event, all proceeds go to the exhibitor. The exhibitor understands that the CCA cannot guarantee any specific amount of sales during event. The exhibitor agrees that the CCA is not held liable for any damages to exhibitors' goods while participating in this event.

The CCA will provide one 8-foot table per exhibitor. The CCA has plenty of folding chairs for exhibitors' use. **Wall space will not be available to exhibitors.** We recommend exhibitors bring easels or displays to best suit their work.

Exhibitors should plan on bringing their own table coverings, decor, and signage. Exhibitors should have their own method for accepting payment. WiFi access is available.

Applications must be received by October 1, 2024. Applicants will be reviewed in the order received, so the earlier the submission the better as space is limited. CCA will be selective in regards to types of exhibitors in order to have a variety of offerings and types of work exhibited. A committee will review applications and inform applicants whether they have been selected to exhibit by October 15, 2024. The nonrefundable registration fee of \$50 will only be due once exhibitor is selected.
